The Career and Technical Education Opportunity Act

The Career and Technical Education Opportunity Act (S.2795) is legislation introduced by Senator Tammy Baldwin (D-WI) that opens the doors of opportunity for career and technical education (CTE) students and supplies regional economies with a highly skilled workforce.

All Career and Technical Education (CTE) Students Should be Able to Access Federal Student Aid

- Career and Technical Education prepares students for a wide range of careers with industry-recognized credentials, postsecondary certificates and degrees.
- CTE is one of the most effective vehicles for responding quickly to labor market changes and the workforce readiness needs of business and industry.
- Currently, students in some short-term CTE programs cannot access federal student aid to help them advance their careers.

Federal Investments Should Support Ready to Work Education

- The CTE Opportunity Act simply allows CTE students enrolled in short-term programs that lead to industry—recognized credentials to qualify for federal Title IV student loans.
- Students enrolled in programs with at least 250 clock hours offered over a minimum of 5 weeks of instruction would be able to access federal student aid including Title IV loans.
- Title IV loans often have better interest rates, stronger consumer protections, a range of income-based repayment options and other features that make them more desirable than private loans for students, families and CTE programs alike.

Support for the CTE Opportunity Act

The *CTE Opportunity Act* is co-sponsored by Senator Tim Kaine (D-VA). Additional support includes the Association for Career and Technical Education (ACTE) and the Wisconsin Technical College System.
