



Wisconsin Leaders Support The Waterfront Community Revitalization and Resiliency Act

“Waterfront cities all along the shores of the Great Lakes applaud Senator Baldwin for introducing the *Waterfront Community Revitalization and Resiliency Act*,” said **Racine Mayor John Dickert, board member of the Great Lakes and St. Lawrence Cities Initiative**. “This bill will help our communities in the heartland of manufacturing continue evolving as economic engines for the region, with water as an economic driver.”

“Waterfronts have great potential to increase value, promote commerce, and add recreational amenities,” said **Milwaukee Mayor Tom Barrett**. “They deserve our protection and our investment.”
