



Support for the Waterfront Community Revitalization and Resiliency Act

“We know from our Brookings Institution work that every dollar spent on water restoration, waterfront access and connection leads to over \$3 in economic development and increased property values,” said **Michigan Economic Center Director and Brookings Institution Nonresident Senior Fellow John Austin**. “I estimate across the Great Lakes states more than a million jobs are already linked to water restoration, waterfront redevelopment and recreation. The *Waterfront Community Revitalization and Resiliency Act* will help more communities reconnect to their water and grow their ‘Blue’ economies.”

"Urban waterfront revitalization is one of those truly win-win situations. Cleaning up neglected waterfronts improves water quality, acts as an economic catalyst for the city and rebuilds a community's cultural ties to water. The return on investment is manifold," says **River Alliance of Wisconsin Executive Director Denny Caneff**.
